Ordinance No. 3062 Summary

On October 22, 2013, the City of Paola, Kansas, adopted Ordinance No. 3062, de-annexing a tract of land located in the Southeast Quarter of Section 21, Township 17 South, Range 23 East, in Miami County, Kansas pursuant to a petition from Randall D. Moser and Hildegard M. Moser, landowners. ORDINANCE NO. 3062

AN ORDINANCE DE-ANNEXING LAND TO THE CITY OF PAOLA, KANSAS.

WHEREAS, the following described land is currently within the corporate limits of the City of Paola, Kansas, and

WHEREAS, a written petition for annexation of the following described land, signed by the owners thereof, has been filed with the City of Paola, Kansas pursuant to KSA 12-504, as amended; and

WHEREAS, this entire property is located in a Special Flood Hazard Area as identified by the Federal Emergency Management Agency; and

WHEREAS, this property is land-locked and there is no public access to the property; and

WHEREAS, this property is currently undeveloped and is likely to remain in an undeveloped state; and

WHEREAS, this property is currently not served by any public services provided by the City of Paola, Kansas and the owners have no intention of requesting City services for this property in the future.

WHEREAS, the governing body of the City of Paola, Kansas, finds it advisable to de-annex and exclude such land from the corporate limits of the City of Paola, pursuant to KSA 12-505;

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PAOLA, KANSAS:

SECTION 1. That the following described land is hereby de-annexed and excluded from the corporate limits of the City of Paola, Kansas:

All that part of the Southeast Quarter of Section 21, Township 17, Range 23, Miami County, Kansas, lying Northwesterly of the Northwest right-of-way line of US 169 Highway.

SECTION 2. That this ordinance shall become effective after its passage, approval, and publication in the official city newspaper pursuant to KSA 12-3001, et seq.
