Ordinance No. 3081 Summary

On March 17, 2015, the City of Paola, Kansas, adopted Ordinance No. 3081, amending water utility rates and bulk water rates as follows: The Water Utility Metered Volume Rate per 100 Gallons Billed Volume is increased from \$0.650 to \$0.730 inside the city limits and is increased from \$0.850 to \$0.930 outside the city limits, effective with the utility billing dated 03/31/2015. Also, the rate for bulk water sold by tank per 50 gallons is increased from \$0.38 to \$0.40, effective 03/31/2015. ORDINANCE NO. 3081

AN ORDINANCE AMENDING TITLE VII UTILITIES, CHAPTER 700 WATER DEPARTMENT, ARTICLE II WATER RATES, SECTION 700.250 METERED VOLUME RATES, AND SECTION 700.270 WATER SOLD BY TANK, TO THE MUNICIPAL CODE OF THE CITY OF PAOLA, KANSAS.

Be it ordained by the City Council of the City of Paola, Kansas, as follows:

SECTION 1. That Section 700.250 is hereby repealed in its entirety and a new Section 700.250 is hereby enacted in its place to read as follows:

SECTION 700.250: METERED VOLUME RATES

A. The following monthly rates are hereby established for the consumption of water, beginning with the utility bill dated March 31, 2015, to-wit:

1. In the City Limits: \$0.730 per 100 gallons
2. Outside the City limits. \$0.930 per 100 gallons

B. These rates do not apply where rates are otherwise specified.

SECTION 2. That Section 700.270 Water Sold By Tank is hereby repealed in its entirety and a new Section 700.270 is hereby enacted in its place to read as follows:

SECTION 700.270: WATER SOLD BY TANK

The following rates are hereby established for tank sales of water at designated locations for tank sale of water for the City, effective March 31, 2015, to wit:

50 gallons \$0.40

SECTION 3. Any and all ordinances in conflict herewith are hereby repealed.

SECTION 4. This ordinance shall become effective after its passage, approval and publication in the official city newspaper.
