Action – Motion to approve the bid of Summit Truck Group in the amount of \$248,506 for two 2018 International Model 7400 SFA 4x2 single axle dump trucks with stainless steel dump beds, spreaders, and plows.

- b. **Consider authorizing city staff to proceed with securing financing in an amount not to exceed \$200,000 for the purchase of two 2018 International Model 7400 SFA 4x2 dump trucks and appurtenances.**

Action – Motion to authorize city staff to secure bank financing in an amount not to exceed \$200,000 for the purchase of two International Model 7400 SFA 4x2 dump trucks with stainless steel dump beds, spreaders, and plows. (The remainder of the purchase price shown in Item 4a will be a down payment from the MERF account.)

- c. **Consider taking formal action to reinstate the 401(a) Money Purchase Plan supplemental retirement plan for full-time employees in non-KP&F covered positions**

Action – Motion to direct staff to prepare a resolution to reinstate the 401(a) Money Purchase Plan for non-KP&F full-time employees as previously covered and to revise Chapter 10 – Retirement Benefits of the City of Paola, Kansas Employee Handbook to reflect the reinstated policy.
