Background

In order to identify areas of hollow sounding delaminated concrete, a chain is dragged across the surface. Carrothers Construction, who was approved at the February 8th meeting to begin repairs, had their General Superintendent and Project Manager drag chains across the pool last week. They have identified a total of 391.64 sq. ft. of what they call punky areas of concrete that will need to be repaired before sandblasting and painting.

Issue

Carrothers Construction had originally bid 20 sq. ft. They are asking for approval of 371.64 sq. ft. additional.

Financial Impact (or Fiscal Note)

This will be an additional \$42,367 to their original bid that is to be paid from the Temporary Notes.

Recommendations

Staff recommends approval of the bid from Carrothers Construction.
